## Barefoot San Francisco 49ers Sweepstakes OFFICIAL RULES

**This Sweepstakes is intended for legal residents aged 21 or older of California. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.**

1. The Barefoot San Francisco 49ers Sweepstakes (the "Sweepstakes") will commence at 12:00:00 AM Pacific Time ("PT") on August 25, 2025 ("Start Date") and end at 11:59:59 PM PT on November 23, 2025. ("End Date"). The period between the Start Date and End Date will be referred to as the ("Sweepstakes Period"). The Sweepstakes Period will be broken out into seven (7) separate entry periods (each, an "Entry Period") as set forth in the Entry Period Chart ("Chart") in Section 3 below. Entries submitted past the expiration of each Entry Period date will not be accepted.
2. **SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. **Limit:** one (1) Entry per person/email address per Entry Period regardless of the method of entry. for a maximum total of seven (7) Entries during the entire Sweepstakes Period. Any person who attempts to participate by using multiple cellular numbers, multiple email addresses, multiple

**Winner Notification:** Sponsor or Administrator will attempt to notify each potential winner (“Potential Winner”) via email on or about the date described in the chart above. Potential Winner must respond within two (2) days of notification attempt. Failure to respond to notification as directed within the stated time will result in forfeiture of the prize.
