LAKE SHORES AND SUMMER POURS SWEEPSTAKES OFFICIAL RULES

This Sweepstakes is intended for legal residents aged 21 or older of Indiana, Illinois, Kentucky, Ohio, Michigan, and Wisconsin only. Void where prohibited or restricted by governing law. Do not enter this Sweepstakes if you are not eligible and are not located in the eligible states at the time of entry.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

The Lake Shores and Summer Pours Sweepstakes (the “Sweepstakes”) will commence at 12:00:00 AM Central Time (“CT”) on July 1, 2026 (“Start Date”) and end at 11:59:59 PM CT on September 8, 2026 (“End Date”). The period between the Start Date and End Date will be referred to as the (“Sweepstakes Period”).

- 1. SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. - 2. ELIGIBILITY.** The Sweepstakes is open to legal residents of Indiana, Illinois, Kentucky, Ohio, Michigan and Wisconsin only who are 21 years of age or older. The entry form may require, but is not limited to, submission of entrant’s date of birth, telephone number, entrant’s first and complete last name (no initials), email address, street address (no PO Boxes), city, state and ZIP Code. Once entrant has completed the foregoing, entrant will have earned one (1) entry (each an “Entry” and collectively “Entries”) into the Sweepstakes. . All Entries must be received by 11:59:59 PM CT on September 8, 2026 to be eligible for entry into the

Sweepstakes. Any Entry that is received after 11:59:59 PM CT on September 8, 2026 will be disqualified and that entry attempt will not be eligible for entry into the Sweepstakes.

Entrant may access the Website directly or by scanning the QR Code found on participating Brand promotional marketing materials. Scanning a QR code is simply an alternative method of accessing the Website and is not required to enter the Sweepstakes; all entries must be submitted via the Website.

To be eligible, the Entry must be in English. 4. WINNER SELECTION AND NOTIFICATION:

Winner Selection: There will be one (1) potential winner during the Sweepstakes. The potential winner will be determined by random drawing conducted by Administrator from among all eligible Entries received on or about September 9, 2026. All decisions of Sponsor and Administrator are final and binding. All Entries are subject to verification, confirmation and compliance with the Official Rules. Odds of winning depend upon the number of eligible Entries received.

Winner Notification: Sponsor or Administrator will attempt to notify the potential winner (“Potential Winner”) via e-mail on or about September 9, 2026. Potential Winner must respond within two (2) days of notification attempt. Failure to respond to notification as directed within the stated time will result in forfeiture of the prize.
