US OPEN SWEEPSTAKES PRESENTED BY CLOS DU BOIS

OFFICIAL RULES

This Sweepstakes is intended for legal residents aged 21 or older of the United States (excluding Utah) and the District of Columbia only. Void where prohibited. Do not enter this Sweepstakes if you are not eligible and are not located in the United States at the time of entry.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

The US Open Sweepstakes presented by Clos du Bois (the “Sweepstakes”) will commence at 12:00:00 AM Pacific Time (“PT”) on July 1, 2026 (“Start Date”) and end at 11:59:59 PM PT on December 31, 2026 (“End Date”). The period between the Start Date and End Date will be referred to as the (“Sweepstakes Period”). The Sweepstakes Period will be broken out into twenty-six (26) separate entry periods (each, an “Entry Period”), and one Grand Prize Entry Period, as set forth in the Entry Period Chart (“Chart”) in Section 3 below. Entries submitted past the expiration of each Entry Period date will not be accepted.

- 1. SPONSOR/ADMINISTRATOR.** The Sweepstakes is sponsored by E. & J. Gallo Winery, 600 Yosemite Blvd., Modesto, CA 95354 (“Sponsor”), and is administered by Avid Inc., d/b/a Avid Marketing Group, 100 Corporate Place, Suite 200, Rocky Hill, Connecticut 06067 (“Administrator”), for Sponsor’s Clos du Bois Wine brand (“Brand”).
- 2. ELIGIBILITY.** The Sweepstakes is open to legal residents of the United States (excluding Utah) and the District of Columbia who are 21 years of age or older. VOID IN UTAH, PUERTO RICO, U.S. VIRGIN ISLANDS, AND OTHER U.S. TERRITORIES AND POSSESSIONS, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW. Directors, officers, employees, and agents of Sponsor, Administrator, United States Tennis Association Incorporated (“USTA”), USTA National Tennis Center Incorporated (“NTC”), and any retail licensees, authorized licensees, wholesale licensees, distributors, and each of their respective parent and/or sister companies, affiliates, subsidiaries, advertising and promotional agencies, and all other corporations, partnerships, or other legal entities or individuals associated with the development, administration, or fulfillment of this Sweepstakes, and the immediate families of such persons (defined as spouse, child, sibling, parent, son-in-law, daughter-in-law, grandparent, so-called “step” or “half” variations of any of the preceding individuals, and all descendants and each of their respective spouses, regardless of where they live), and those living in their same households, whether or not related, are ineligible to enter, win or collect prizes in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws, regulations, and ordinances.
- 3. TO ENTER.** The Sweepstakes begins at 12:00:00 AM PT on July 1, 2026, and ends at 11:59:59 PM PT on December 31, 2026. To enter visit <https://www.closdubois.com/2027-us-open-sweepstakes.html> (“Website”) and follow the instructions to complete and submit the entry

form during the Sweepstakes Period. The entry form may require, but is not limited to, submission of entrant’s date of birth, telephone number, entrant’s first and complete last name (no initials), email address, street address (no PO Boxes), city, state and ZIP Code. Once entrant has completed the foregoing, entrant will have earned one (1) entry (each an “Entry” and collectively “Entries”) into that Entry Period. Entry must be received by 11:59:59 PM PT by each respective Entry Period End Date listed in the Chart below to be entered into that Entry Period. Any Entry that is received after 11:59:59 PM PT on December 31, 2026 will be disqualified and that entry attempt will not be eligible for entry into the Sweepstakes.

Entrant may access the Website directly or by scanning the QR Code found on participating Brand promotional marketing materials. Scanning a QR code is simply an alternative method of accessing the Website and is not required to enter the Sweepstakes; all entries must be submitted via the Website.

Limit: Entrant may enter once per person/email address per Entry Period. 4. WINNER SELECTION AND NOTIFICATION.

Winner Selection: There will be a maximum of twenty-seven (27) total winners during the Sweepstakes Period. There will be one (1) First Place Prize Winner each Entry Period One (1) through Entry Period Twenty-Six (26) and one (1) Grand Prize Winner for the Grand Prize Entry Period. Winners will be determined by a random drawing conducted by Administrator from among all eligible Entries received by Administrator on or about the date stated in the chart below. All decisions of Sponsor and Administrator are final and binding. All Entries are subject to verification, confirmation and compliance with the Official Rules. Odds of winning a prize for Entry Period One (1) through Entry Period Twenty-Six (26) depend upon the number of eligible Entries received during the applicable Entry Period and any NON-WINNING ENTRIES that roll over from previous Entry Periods. Winner Notification: Sponsor or Administrator will attempt to notify each potential winner (“Potential Winner”) via e-mail on or about the date described in the chart above. - 5. PRIZE(S) AND APPROXIMATE RETAIL VALUE ("ARV").** There will be a maximum of twenty-seven (27) total prizes awarded for the Sweepstakes. There will be twenty-six (26) First Place Prizes and One (1) Grand Prize. The total ARV for all prizes that may be awarded during the Sweepstakes is \$9,600.

Entry Periods One (1) through Entry Period Twenty-Six (26) Prize(s): Entry Period One (1) through Entry Period Twenty-Six (26) will each consist of one (1) First Place Prize. Each First Place Prize is a Clos du Bois and US Open kit that includes: One (1) Clos du Bois branded mini canvas tote, one (1) Clos du Bois and US Open branded embroidered hat, two (2) Clos du Bois branded stone tile coasters, three (3) Clos du Bois and US Open branded tennis balls, one (1) set of Clos du Bois branded wine glass charms, and two (2) Clos du Bois and US Open branded cups. Grand Prize Entry Period Prize: Grand Prize Entry Period will have a maximum of One (1) GRAND PRIZE. The Grand Prize will consist of a trip for winner and one (1) guest (both aged 21 or over) to the 2027 US Open Tennis Championships Men's Singles Final at the USTA Billie Jean King National Tennis Center, in Flushing, NY, to be held on or around September 12, 2027 ("US Open Tennis Championships"). The trip will include roundtrip airfare for winner and one guest from a Sponsor-specified major airport nearest winner's residence to a Sponsor-specified major airport nearest Flushing, NY, ground transportation to and from the airport, two (2) night standard accommodations (single room, double occupancy, room and tax only) to be selected by Sponsor, and two (2) courtside tickets to the 2027 US Open Tennis Championships Men's Singles Final on or around September 12, 2027. The total ARV of the Grand Prize to be awarded during the Sweepstakes Period is \$6,800. ARV is subject to change based on city of departure, and other market conditions at the time of prize fulfillment. Tickets are subject to the terms set by the respective issuer. subsidiaries, as they may be updated from time to time. Each winner and winner's guests must also comply with all applicable 2027 US Open Tennis Championships Men's Singles Final ticket terms and conditions.

Travel Safety Advisory: Since travel and tourism are constantly changing, the winner and guest(s) shall consult the U.S. State Department's website at travel.state.gov regarding the latest information concerning traveler safety, security, and health advisories and the Center for Disease Control website for guidance regarding COVID-19 <https://www.cdc.gov/coronavirus/2019-ncov/travelers/travel-during-covid19.html>. The winner and winner's guest(s) are responsible for checking the travel protocols before they depart and ensuring that they fully understand and comply with any such protocols. For example, some destinations may require obtaining a negative COVID-19 viral test a certain number of days before and upon return travel. The Sponsor, Administrator and other Released Parties shall not be responsible for any additional costs incurred for any pre-travel or post travel requirements respecting COVID-19 or other communicable diseases.

TRIP TERMS: Advanced reservations required. All other expenses (including, without limitation, ground transportation, personal expenses (optional excursions, spa treatments, souvenirs), telephone charges, meals and beverages, and all federal, state and local taxes (including applicable income taxes) and fees incurred are the winner's/guests' sole responsibility. The winner will be responsible for applicable taxes and fees. Trip is subject to availability; restrictions and blackout dates apply.
